2.1. Classification of the substance or mixture

Section 4: First aid measures

4.1. Description of first aid measures

Skin contact: Remove all contaminated clothes in contact with skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Obtain medical attention if irritation persists

Eye contact: Bathe the eye with running water for 15 minutes. Remove any contact lenses and open eyes wide apart. Seek medical advice if irritation persists

Ingestion: Wash out mouth with water. Do not induce vomiting. Give 1 cup of water to drink every 10 minutes. If patient feels unwell seek medical attention

Inhalation: Not a problem in normal use. If irritation is experienced, mouth and throat may be rinsed with water. Get medical advice if irritation continues.

4.2. Most important symptoms and effects, both acute and delayed

Skin contact: There may be irritation and redness at the site of contact. Blistering may occur.

Eye contact: There may be pain and redness. The eyes may water profusely. The vision may become blurred. Corneal burns may occur. May cause permanent damage.

Ingestion: There may be soreness and redness of the mouth and throat. Corrosive burns may appear around the lips.

Inhalation: There may be shortness of breath with a burning sensation in the throat. Exposure may cause coughing or wheezing.

4.3. Indication of any immediate medical attention and special treatment needed

Environmental precautions: Do not discharge into rain water drains or rivers. Contain the spillage using bunding.
